Purpose Of the Role:

The Feminist Research & Policy team is a key part of ActionAid UK's aim to become a feminist, anti-racist, decolonial organisation. The team is important in the delivery of ActionAid UK's strategy to promote a world where women and girls are valued, live free from violence, and can exercise their rights to economic security, wellbeing, safety, equality and voice. These operations are comprised of policy, research and technical advisers who advance policy perspectives and programme led learning to ActionAid UK's target donors, influencers, academic audiences and policy makers. A key purpose of the team is the provision of high-quality research, technical advice and policy development rooted in AA programme and policy work, applying feminist principles to research and analysis. Technical advisers in the team also provide policy, advocacy and influencing advice and technical advice to support resource mobilisation and programme quality (when expertise is not in the Federation.

The role demands a specialist who will bring policy, research skills, networking ability and a spirit of collaboration to ActionAid UK as it delivers on its Strategy

Main Accountabilities:

Policy Analysis & Research

- Support the implementation of AAUK's Women's Economic Justice (WEJ)
 portfolio with a focus on Global South informed policy analysis and
 pathways, alliance building and transnational solidarity.
- Share programmatic learnings on movement building, system change and narrative disruption on women's economic justice to inform all research and policy work
- Plan and manage policy projects with supervision, including collaborative research and other initiatives with colleagues and partners in and the Global South.
- Undertake policy analysis and research as specified by the Senior Policy Specialist on WEJ
- Analyse research findings to help shape policy recommendations and influence activities.
- Ensure policy research is informed, shaped and led by a strong southern feminist analysis and AA programme work, working with AA staff and other partners in the Global South
- Undertake regular monitoring of policy and political developments in assigned focus areas
- Support the planning and delivery of annual activities and new projects based on learning and engagements related to WEJ



Policy Promotion & Representation

- To support ActionAid UK's contribution to Federation-wide initiatives aligned to AAUK strategy for Women's Economic Justice work
- Write on request blog posts and use other social media tools to communicate ActionAid policy and thinking.
- With supervision, communicate ActionAid policy and research work through writing articles, online debate

- Work with AA International staff and country programmes to implement joint advocacy projects and strategies.
- Provide economic justice policy support and guidance on request to the advocacy and campaign teams ensuring alignment with economic justice asks
- Provide policy support in advocacy engagement of government officials and peer technical/programme specialists in FCDO and other governmental institutions in collaboration with the advocacy unit and in accordance with AAUK's political strategy and on request.
- Work with the Advocacy team to ensure Women's Economic Justice policy asks and calls to action are included in our influencing work and are Global South informed
- Attending relevant events in support of AAUK and WEJ
- Participate in and support relevant coalitions and movements to our WEJ work
- Support the Young Urban Women's programme country teams to design, implement, and evaluate high-impact advocacy campaigns that
- advance the programmes objectives and amplify young women's voices.

- Experience of networking and contact building in political, academic or NGO settings.

- A strong commitment to ActionAid's values, particularly those on women's rights

- Experience of living and working in the "Global South", especially regions where we are funding programmes & projects
- Experience of working for an INGO
- A post graduate degree in a relevant subject in particular feminist policy, economics, trade justice, etc.
- Experience of being published in academic journals.
- Fluency in French and/or a second language spoken in developing countries, in addition to English.
- Degree in a subject appropriate to international development.
